




Fig. 1. Percentage of Surface Water Quality of China in 2016










#### 调沧江-湄公河环境合作 Lancang-Mekong Environmental Cooperation

On May 23th, 2016, in the First Lancang-Mekong Cooperation Leaders' Meeting, Premier **LI Keqiang** put forward the initiative that "China wishes to set up, in collaboration with Mekong countries, an environmental protection cooperation center, to strengthen technical cooperation, personnel exchanges and information sharing, and promote green, coordinated and sustainable development in the sub-region".



# Early Harvest Program—Capacity Building 能力建设项目

- Workshop for China-Laos Environmental Management was held in Yunnan in May of 2016
- International Workshop for Lancang-Mekong Ecosystem Management was held in Beijing in September of 2016
- The China-Cambodia Environmental Impact Assessment Capacity Building Seminar was held in Beijing in November of 2016.
- Capacity Building Workshop for **Lancang-Mekong Industrial Gam Emission Standards and Management** was held in Beijing in February of 2017.
- Capacity Building Workshop for **Lancang-Mekong Water Quality Monitoring** and Consultation on Lancang-Mekong Environmental Cooperation Strategy was held in Beijing in March of 2017
- China-Cambodia Aquatic Environment Management and Practice Seminar was held in Phnom Penh on June of 2017




